Consequent upon the revision of seniority lists of Inspectors as on 31.12.2016 & 31.03.2018 vide this office letter F.No. GCCO/II/26(1)2022/Admn./841 dated 23.08.2023 in terms of the Board's letters F.No.A32018/02/2022-Ad.IIIA dated 10.11.2022, 03.02.2023 and 23.06.2023 readwith Board's earlier letter F.No. A.22015/34/80-Ad.III B dated 20.05.1980, F.No. A.23011/3/97-Ad.IIIA dated 05.06.1998, F.No. A.22015/23/2011-Ad.III.A dated 27.10.2011 and DoPT's O.M. No. 20011/1/2012-Estt (D) dated 04.03.2014 which was issued in pursuance of Hon'ble Supreme Court judgment dated 27.11.2012 in Civil Appeal No. 7514-7515/2005 in the case of N.R. Parmar Vs. The aforesaid officers (Sl. No. 19 to 28 of above list) should submit their joining report on the said promotion to the concerned controlling officers under intimation to this office. They are posted at their present place of posting on the said promotion to the grade of Superintendent, Group 'B' (Gazetted) till further orders.

4. On the aforesaid notional promotion to the grade of Superintendent, Group 'B' (Gazetted) on regular basis, pay of the officers should be fixed under F.R. 27 but **no arrears** would be admissible till date of joining in the cadre of Superintendent, Group 'B' (Gazetted) in terms of Para 18.4.3 of the DPC guidelines regarding review DPC.

5. Consequent upon the said promotion, the above mentioned officers, may exercise option for fixation of their pay under FR-22 (1) (a) (1) within one month from the date of their promotion in terms of Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training O.M. No. 13/02/2017-Estt. (Pay-1) dated 27.07.2017. No request for condonation of delay in submitting the option after the stipulated period will be entertained.

6. The promotion of the said officers shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the **Jarnail Singh** batch of cases in the matter of reservation in promotion.

7. The aforesaid promotion of officers is subject to the outcome of W.P.C.T No. 261 of 2008 filed by Shri Samiran Roy & Others V/s. Union of India and others before the Hon'ble High Court of Calcutta.

8. The aforesaid promotion is also subject to the final decision to be taken by the competent authority with reference to Board's letter F. No. 32022/96/2015-Ad.III A (Pt.), dated 12.05.2016 and Order dated 26.09.2022 of Hon'ble CAT, Jaipur Bench, Jaipur in O.A. No. 291/00414/2016 filed by Shri Ajay Agarwal, Superintendent and others.

9.1 This order is subject to the final outcome of O.A. No. 453/2023 filed by S/Shri Manoj Kumar Meena, Arun Kumar Bauddh and Shiv Prakash before Hon'ble CAT Bench, Jaipur.

9.2 This order is also subject to the final outcome of O.A. No. 440/2023 & CW No. 38444/2023 filed by Ms. Lalita Meena before Hon'ble CAT Bench, Jaipur and Hon'ble Rajasthan High Court, Jaipur respectively.

9.3 This order is also subject to the final outcome of O.A. Nos. 387/2023 filed by Shri Chhutan Lal Meena & 4 others and 470/2023 filed by Shri Mukesh Kumar Mann before Hon'ble CAT Bench, Jaipur and OA. Nos. 296/2023 filed by Shri Pritam Sharma & 297/2023 filed by Shri Narendra Kumar Sharma before Hon'ble CAT Bench, Jodhpur.

10. The promotion of the said officers are subject to outcome of any litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion/reservation before any judicial forum.

11. The Principal Commissioner/Commissioner, CGST & Central Excise and Customs, Jaipur Zone, Jaipur and all other supervisory authority concerned shall ensure that if any of the officers whose name has figured at Sl. No. 19 to 28 in above list, is under suspension or facing any charge sheet or prosecution, he/she should not be allowed to assume charge of the post of Superintendent, Group 'B' (Gazetted) and this fact should be reported to this office immediately. In case, the officers are clear from the vigilance angle, their joining report on promotion or forego promotion request, as the case may be, forwarded to this office, at the earliest.
