

- iii. Place/ Person for submitting bid: **Office of the Assistant Commissioner, Central Goods & Service Tax Division-G, Todi Nagar, Sanwali Road, Sikar.** The cover of the bid documents should be prominently super-scribed with words "QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE".

- iv. Bid Opening date, Time and venue: **23<sup>th</sup> June 2022, 11:00AM in Room No. 1.01, Assistant Commissioner, Central Goods & Service Tax Division-G, Sikar.**

**3. Terms and conditions:**

- i. Staff and officers of Central Board of Indirect Taxes & Customs and Govt. Servants are not eligible to participate in the bidding process.
- ii. Bid security (EMD) of Rs.10,000/- (**Rs. Ten thousand only**) may be in the form of Demand Draft/ Pay order drawn in favour of "**Administrative Officer, Central Goods & Service Tax Division-G, Sikar**" must be enclosed with the bid. Bids without EMD or in any other form i.e. cheque or cash etc. will not be considered.
- iii. The successful bidder will be required to deposit the bid amount by means of Cash/DD drawn in favor of **Administrative Officer, Central Goods & Service Tax Division-G, Sikar within 5 working days from the date of the acceptance of the bid by the Department.**
- iv. If it is found that the amount quoted by the successful bidder (i.e. highest bidder) is less than the reserve price fixed by the Valuation Committee or the total number of bidders was less than three the bid may be treated as cancel.
- v. The Earnest Money of the successful bidder will be released only after the deposit of sale proceeds. Earnest Money will be forfeited if he fails to honour the bid.
- vi. The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status viz. Aadhar Card/ PAN Card/ Passport in case of individual and Registration/ GST Certificate in case of firms etc.
- vii. The successful bidder have to remove the vehicles at his own cost on the same day of final payment, failing which resale of the vehicle will be undertaken at the risk and cost of the defaulter.
- viii. The vehicle will be disposed off on "**as is where basis is**" and no guarantee for its worthiness or quality will be given by this Department.

- ix. The Department will not be responsible for any lapse in this regard.
- x. The bidders will not be allowed to withdraw their bids, failing which their Earnest Money will be forfeited.
- xi. The undersigned reserves the right to accept or reject any/all of the quotations without assigning any reason.
- xii. All taxes/levies etc. will be borne by the buyer over and above the bid price.
