In terms of Board's letter F.No. A-12018/01/2012.Ad.III.B dated 15.05.2023, a Review DPC was held on 16.05.2023 in respect of DPC held on 30.12.2022 for promotion to the grade of Executive Assistant, Group 'B' (Non-Gazetted) from amongst Tax Assistants, Group 'C' for filling up the vacancies for the vacancy year 2022.

2. As per the recommendations of the aforesaid Review DPC meeting held on 16.05.2023, the following Tax Assistants, Group 'C' in the pay scale/band of Rs. 5200-20200 with grade pay of Rs. 2400/- in PB-1 (Revised as Level-4 in the pay matrix of Rs. 25500-81100) are hereby promoted to the grade of Executive Assistant, Group 'B' (Non-Gazetted) on regular basis in the pay scale of Rs. 9300-34800 (PB-2) with grade pay of Rs. 4200/- (Revised as Level-6 in Pay Matrix Rs. 35400-112400) on notional basis from the date mentioned below in column 5:

3. The aforesaid officers should submit their joining report on the said promotion to the concerned controlling officers under intimation to this office. They are posted at their present place of posting on the said promotion to the grade of Executive Assistant, Group 'B' till further orders.

4. On the aforesaid notional promotion to the grade of Executive Assistant on regular basis, pay of the officers should be fixed under F.R. 27 but no arrears would be admissible till date of joining in the cadre of Executive Assistant in terms of Para 18.4.3 of the DPC guidelines regarding review DPC.

5. Consequent upon the said promotion, the above mentioned officers, may exercise option for fixation of their pay under FR-22 (1) (a) (1) within one month from the date of their promotion in terms of Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training O.M. No. 13/02/2017-Estt. (Pay-1) dated 27.07.2017. No request for condonation of delay in submitting the option after the stipulated period will be entertained.

7. The promotion of the said officers shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the matter of reservation in promotion.

8. The Principal Commissioner/Commissioner, CGST & Central Excise and Customs, Jaipur Zone, Jaipur and all other supervisory authority concerned shall ensure that if any of the officers whose name has figured in above list, is under suspension or facing any charge sheet or prosecution, he/she should not be allowed to assume charge of the post of Executive Assistant, Group 'B' (Non-Gazetted) and this fact should be reported to this office immediately. In case, the officers are clear from the vigilance angle, their joining report on promotion or forego promotion request, as the case may be, forwarded to this office, at the earliest.


