



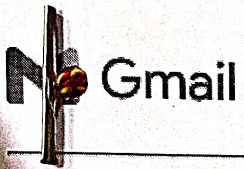

2. In reference to the information desired in supplement to the Parliament Question (LS) Diary No. 1 (Starred), point-wise reply of the desired supplement information for Jaipur Zone is as under:

(1) (a) Total 96 Dwelling/Housing units have been purchased as per details in the table below. An amount of Rs. 4.52 Cr was spent on purchase of these units. 75 out of 96 are lying vacant due to dilapidated condition.

Details are as below:-

Commissionerate	Total No. Of Dwelling/Housing Units	Occupied	Vacant
Jaipur	12	11	1
Udaipur	84	10	74*
Total	96	21	75

* Note: The vacancy is due to the reason that the dwelling units are not habitable. Out of 84 units, only 10 units are occupied. Further, in remaining 74 units 10 units are under renovation process. A proposal to sell existing 50 quarters and acquire new quarters in their place was submitted to DGHRD. A fresh demand survey is being conducted to re-examine the proposal.

Kindly find attached, the information/inputs as received from Jaipur CC's office of GST & CE for Starred PQ(LS) No. 1 to be answered on 4th December, 2023. The following further details are required:

1. The reply states about Jaipur Zone. We would require similar details for Rajasthan as a whole and also all zones.
2. The reply mentions about 4 complaints that were received. The dates of these complaints have not been mentioned. We would require those details as well.
3. Wrt to the complaint at S.No.4, the action taken is mentioned. About other three, no specific action is mentioned.
4. The reply gives details of 'own residential pool' but it is not clear if this pertains to only Jaipur and Udaipur or all Rajasthan.
5. The reply mentions about the proposal for auction of 50 houses - what is the current status at DGHRD? If the proposal is under process, this would become a parliamentary assurance and we may need to again revert back to you with details when a decision is taken to auction them.

We may meet Commissioner (Coord) today, preferably before lunch so that these are sorted out and we are able to prepare a robust draft reply and discuss the same with MoS in tomorrow's briefing meeting.


