- (A) While working in the CGST & CE, Jaipur Zone, all kinds of payments to Sh. Himanshu Sharma, Superintendent, towards his pay and allowances will have to be borne by his parent Zone/ Commissionerate. His services will also be borne by his parent Zone i.e. he will be on the working strength of his parent Zone. He will not be entitled to any kind of special pay, allowance etc.
- (B) No TTA and Joining Time will be admissible to him in this event of transfer on 'Loan Basis', since this transfer is being allowed on his own request.
- (C) On transfer on 'Loan Basis', he will not be entitled for promotion, confirmation, seniority etc. in the CGST & CE, Jaipur Zone.
- (D) He will be liable to be transferred anywhere within the jurisdiction of CGST & CE, Jaipur Zone, Jaipur.
- (E) He is liable to be repatriated to his parent Zone at any time without assigning any reason.

2. On having accepted the above terms and conditions and if he is clear from vigilance angle, he may be relieved by his parent Zone with the directions to report to the undersigned, not later than **18.09.2022**, falling which this order will liable to be cancelled without any further intimation.
