Consequent upon the said promotion, the above mentioned officer, may exercise option for fixation of her pay under FR-22 (1) (a) (1) within one month from the date of her promotion in terms of Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training O.M. No. 13/02/2017-Estt. (Pay-1) dated 27.07.2017. No request for condonation of delay in submitting the option after the stipulated period will be entertained.

4. The promotion of the said officer shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the Jarnail Singh batch of cases in the matter of reservation in promotion.

The supervisory authority concerned shall ensure that if the officer whose name figures in above list, is under suspension or facing any charge sheet or prosecution, she should not be allowed to assume charge of the post of Superintendent, Group 'B' (Gazetted) and this fact should be reported to this office immediately. In case, the officer is clear from the vigilance angle, her joining report on promotion or forego promotion request, as the case may be, forwarded to this office, at the earliest.
