

Consequent upon granting of Non-Functional Upgradation in the grade pay of Rs. 5400/- in PB-2 (Revised as level-9 in Pay Matrix Rs. 53100-167800) as per column 6 of the aforesaid table, the benefit of Non-Functional Upgradation (NFU) / 2nd / 3rd MACP granted earlier in the grade pay of Rs. 5400/- in PB-2 (Revised as level-9 in Pay Matrix Rs. 53100-167800) as per Column No. 5 of the table, is hereby withdrawn.

any. should be recovered from their monthly salary / pension immediately as and when, noticed as per Government's rules and regulations.


