A Review DPC was held on 16.07.2025 in respect of Supplementary DPC dated 06.06.2023 for the vacancy year 2023 and Original DPC dated 30.12.2024 for the vacancy year 2025 for regular promotion to the grade of Tax Assistant. As per the recommendations of the aforesaid Review DPC, the following LDCs (presently working as Tax Assistant) are hereby promoted to the grade of Tax Assistant, Group 'C' in Level-4 of Pay Matrix Rs. 25,500/- to Rs. 81,100/- plus other allowances, as admissible, on regular basis from the date mentioned below in column 6:

2. On the aforesaid notional promotion of officer mentioned at Sl. No. 1, to the grade of Tax Assistant, Group 'C' on regular basis, pay of the officer should be fixed under F.R. 27 but no arrears would be admissible till date of joining in the cadre of Tax Assistant, Group 'C' in terms of Para 18.4.3 of the DPC guidelines regarding review DPC.

3. On promotion, benefit of option for fixation of pay in the promotional post, if admissible, shall be available to the officers named above in terms of provisions contained in the DoPT's O.M. No. DOPT-1667551701810 dated 13<sup>th</sup> September 2022.

They may exercise the option, if benefit of the same is admissible, within one month from the date of their promotion. No request for condonation of delay in submitting the option after the stipulated period will be entertained.

4. This order is subject to the final outcome of O.A. No. 672/2024 filed by Shri Man Singh and others before Hon'ble CAT Bench, Jaipur.

5. The promotion of the said officers shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the **Jarnail Singh** batch of cases in the matter of reservation in promotion.

6. The promotion of the said officers is subject to outcome of any litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion/reservation before any judicial forum.
