The information in respect of two similar online RTI applications bearing registration No. GSTJP/R/E/23/00104/1 and No. GSTJP/R/E/23/00106/1 both dated 22.05.2023 filed by you, in respect of Office of the Chief Commissioner of CGST & CX, Jaipur Zone is as under –

Para 1 to 6. *The information sought vide these points is not available or maintained, thus cannot be provided. In this regard Hon'ble CIC in the case of Sh. Ashok Kumar Sharma vs B.H.E.L. dated 25 July, 2008 and in various cases has held that information which is not readily available or maintained, cannot be furnished.*

Also, the applicant has desired personal information in para 5 and has not shown larger public interest. As per section 8(1)(j) of RTI Act 2005 information which relates to personal information the disclosure of which has no relationship to any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information Officer or the State Public Information Officer or the appellate authority, as the case may be, is satisfied that the larger public interest justifies the disclosure of such information. Therefore, information sought cannot be provided as the same falls u/s 8(1)(j) of RTI Act 2005 and further there seems no larger public interest.
