



The aforesaid regular promotion of the officers is subject to the final decision of the Board in respect of Order dated 10.08.2018 of the Hon'ble CAT, Jaipur Bench, Jaipur in OA No. 291/233/2018 filed by Shri Manish Chaudhary and Another, as communicated by the CBIC vide its letter F.No. CBEC-10C18/28/2018-Ad.IIB dated 12.07.2019.

Consequent upon the above promotion, the above officers may exercise option for fixation of their pay under FR-22(1) (a) (1) within one month from the date of their promotion in terms of Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training O.M. No. 13/02/2017-Estt. (Pay1) dated 27.07.2017. No request for condonation of delay in submitting the option after the stipulated period will be entertained.
5. The above promoted officers must be relieved immediately to join at their new place of posting (on promotion) under intimation to the CCO. No representation whatsoever shall be entertained before they join at new place of posting. Further specific postings of these officers will be decided by the concerned Principal Commissioner/Commissioners.
6. The aforesaid regular promotion of the officers is subject to the outcome of W.P.C.T No. 261 of 2008 filed by Shri Samiran Roy & Others V/s. Union of India and others before the Hon'ble High Court of Calcutta.
7. The aforesaid promotion is also granted subject to the final outcome of the review DPC, if held for promotion to the grade of Inspector with reference to Board's letter F. No. 32022/96/2015-Ad.III A (Pt.) dated 12.05.2016. The Hon'ble CAT, Jaipur Bench, Jaipur granted the stay on the said letter dated 12.05.2016 vide Order dated 03.06.2016 in O.A. No. 291/00414/2016 filed by Shri Ajay Agarwal, Superintendent and others before the Hon'ble CAT, Jaipur Bench, Jaipur against the said letter dated 12.05.2016.
8. The promotion of the said officers is subject to outcome of any other litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion before any judicial forum.
9. The promotions of the said officers shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the matter of reservation in promotion.


