Trade Notice No.01/ 2024 Dated: 11.06.2024

The Trade and Industry are hereby informed that the Central Board of Indirect Taxes & Customs (CBIC), has amended the Notification No.2/2017- Central Tax dated 19th June, 2017, vide Notification No. 10/2024-Central Tax dated 29.05.2024 and Notification No. 11/2024-Central Tax dated 30.05.2024. The Notifications have come into force with effect from 30.05.2024. The notifications lay down the jurisdiction of various Commissionerates under the Zone with reference to creation of new districts in the state of Rajasthan (Annexure-A). The notifications are available on the CBIC website www.cbic.gov.in, which may be referred to.

2. It may be noted that there is no change in the jurisdiction of Jodhpur and Udaipur Commissionerates. However the newly formed Kotputli-Behror District has been assigned to Alwar Commissionerate w.e.f 30.05.2024. As a result the taxpayers falling in the Kotputli, Viratnagar and Paota (Newly created) Tehsils will now stand shifted to CGST Division Behror. Further the taxpayers falling in Amber Tehsil of Central GST Range-XXI are being allocated to Central GST Range-XXII. The re-organized CGST Range-XXII will now have jurisdiction over Amber and Shahpura Tehsils and known as "Central GST Range-XXII- Amber Range" instead of "Central GST Range-XXII- Kotputli".

3. Necessary changes in the systems are underway. In the transitional period the officers exercising jurisdiction over the taxpayers shall continue to exercise their power as additional charge. As such, the Trade and Industry should approach the existing officers till new arrangements are in place.

4. The Trade Notice No. 06/2017 dated 22.06.2017 issued by the Commissioner, Central Goods & Service Tax Jaipur in respect of jurisdiction of erstwhile Central GST Range-XXII- (Kotputli) and Central GST Range-XXI, Jaipur and Trade Notice No. 03/2017 dated 21.06.2017 issued by the Commissioner, Central Goods & Service Tax Alwar in respect of newly created and transferred CGST Range-Kotputli (in Alwar Commissionerate) stand amended accordingly (Annexure-B). The Principal Commissioner, CGST Jaipur and Commissioner CGST Alwar will issue revised Trade Notices.

5. The Trade & Industry Associations/Chambers of Commerce are requested to bring the contents of the Trade Notice to the notice of all their members.
