2. All the above mentioned officers must be relieved by the respective Principal Commissioners/ Commissioners/ Controlling Officers, by 14-06-2019 positively and the officers transferred should be directed to join their new place of posting, by 20-06-2019 positively. A consolidated report regarding relieving / joining of the officers, should reach this office by 24-06-2019, from all the Commissionerates.

3. It is further directed that Orders indicating Specific Charge /Postings within the Commissionerate, should be issued by the respective Commissioners by 14-06-2019 positively. While issuing Orders for specific charge/postings, the Transfer Policy guidelines 2018 and the History of Posting (HoP) of the officers should be kept in mind, so as to ensure proper rotation – sensitive & non-sensitive norms etc. as prescribed by the instructions issued by CVC/ CVO. In case of any deviation from the Transfer /Placement Guidelines, prior approval of the Chief Commissioner should be taken by the respective Commissioners.

4. The officers, who have been given extension at the station or whose request for premature transfer has been considered, should be posted to non-sensitive charge only.

5. The Commissioners should ensure that before relieving the officers, they hand over their charge under proper Handing Over/ Taking Over note. List of all urgent and time bound matters, pertaining to the important and necessary work should be prepared and handed over to the controlling officer and a copy of the same should be handed over to the officer taking over the charge by the officer handing over the charge. The officers should also make a note for the successor on issues of current importance, urgency of actionable points, critical issues as envisaged in DOP&T OM No. 13024/01/2014-(Trg-Ref) dated 26.09.2014.




6. Since the transfers of officers mentioned at S.No. 87 to 105 have been made on their own request, they shall not be entitled for any TTA or joining time either at the time of joining their new place of posting in AGT 2019 or at the time of their repatriation in the subsequent AGT, as the case may be.

7. The officers mentioned at S. No. 106, 108, 112, 114, 115, 118 to 120 who were transferred in AGT 2018, as per Establishment Order No. 43/2018 dated 28.04.2018 on their own request, before completion of their station tenure, and who are being repatriated now, shall not be entitled for any TTA or joining time as their transfers in AGT 2018 were done on their own request.

8. All the representations/requests received in the grade of Superintendent stand disposed of, after issuance of this order.
