3. The promotion of the said officers shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the **Jarnail Singh** batch of cases in the matter of reservation in promotion.



5. The aforesaid promotion is also subject to the final decision to be taken by the competent authority with reference to Board's letter F. No. 32022/96/2015-Ad.III A (Pt.), dated 12.05.2016 and Order dated 26.09.2022 of Hon'ble CAT, Jaipur Bench, Jaipur in O.A. No. 291/00414/2016 filed by Shri Ajay Agarwal, Superintendent and others.

6. The promotion of the said officers is further subject to outcome of any other litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion before any judicial forum.

7. The Principal Commissioner/Commissioner, CGST & Central Excise and Customs, Jaipur Zone, Jaipur and all other supervisory authority concerned shall ensure that if any of the officers whose name has figured in above list, is under suspension or facing any charge sheet or prosecution, he/she should not be allowed to assume charge of the post of Superintendent, Group 'B' and this fact should be reported to his office immediately.

This issues with the approval of the Principal Commissioner, CGST & Central Excise, Jaipur.


