**ESTABLISHMENT ORDER NO. CCU - 49/2023
DATED: 25.10.2023**

As per findings kept in sealed cover by the DPC held on 22.03.2007 (Reviewed on 27.02.2012) for regular promotion to the grade of Superintendent Group 'B' (Gazetted) and in terms of DOPT's O.M. No.22011/4/91-Estt. (A) dated 14.09.1992, **Shri M. K. Gautam**, Inspector (Retired from Customs Commissionerate, Jaipur), is hereby promoted on regular basis to the grade of Superintendent Group 'B' (Gazetted) (in the pay band / scale of Rs.9300-34800 (PB-2) with corresponding grade pay of Rs.4800/-) w.e.f 23.03.2007 on notional basis when his junior Shri S.N. Sethi, Inspector joined as Superintendent, Group 'B' on adhoc basis from the select panel prepared by the aforesaid DPC held on 22.03.2007 (Reviewed on 27.02.2012). Further, the placement of Shri M.K. Gautam is fixed above to Shri S. N. Sethi in the seniority list of Superintendents, Group 'B' issued as on 31.01.2008 vide F.No. II-34(1)CCU/JPR/2006 dated 26.02.2008 of the Joint Commissioner (P&V), Central Excise, Jaipur-I.

Since, Hon'ble Court ACJM No. 1, Bikaner vide Order dated 15.09.2022 in criminal case No. 50/2019 (Rajasthan State Vs. Mahesh Kumar Gautam and others), acquitted Shri M.K. Gautam giving benefit of doubt and on the basis of Rajinama, therefore, Shri M.K. Gautam, Inspector (Now retired), is not entitled for arrears of pay on the said notional promotion in terms of para-3 of the DOPT's O.M. No.22011/4/91-Estt. (A) dated 14.09.1992.

The aforesaid promotion of Shri M. K. Gautam is subject to outcome of W.P.C.T No. 261 of 2008 filed by Shri Samiran Roy & Others V/s. Union of India and others before Hon'ble Calcutta High Court.

This issues with the approval of the competent authority.
