With reference to the information sought the pointwise reply is as under:-

Point No.1: DoPT's OM No. 36012/1/2020-Estt.(Res.-II) dated 17.05.2022 regarding reservation in promotion to PwBDs is being followed in Jaipur Zone.

Point No.2: A copy of notesheet regarding reporting of vacancies for the post of Inspector for CGLE-2023 is enclosed (total 3 pages).

Point 3&4: The Department of Empowerment of Persons with Disabilities (DEPwD) vide Notification No. 38-16/2020-DD-III dated the 4th January, 2021 has identified posts suitable for being held by PwBDs and the physical requirement for all such posts, including Inspector (Central Excise & Customs). The Notificaiton dated 04.01.2021 ibid is available on the website of DEPwD i.e. <https://depwd.gov.in/> . The reservation in promotion is not applicable in the grade of Inspector (Central Excise & Customs) as element of direct recruitment is more than 75%.”
