3. The aforesaid promotion is also subject to the final decision to be taken by the competent authority with reference to Board's letter F. No. 32022/96/2015-Ad.III A (Pt.), dated 12.05.2016 and Order dated 26.09.2022 of Hon'ble CAT, Jaipur Bench, Jaipur in O.A. No. 291/00414/2016 filed by Shri Ajay Agarwal, Superintendent and others.

4. The promotion of the said officers is further subject to outcome of any other litigation/cases etc. pending presently or which may arise in future on the issue of seniority/promotion/reservation before any judicial forum.

5. The Principal Commissioner/Commissioner, CGST & Central Excise and Customs, Jaipur Zone, Jaipur and all other supervisory authority concerned shall ensure that if any of the officers whose name has figured in above list, is under suspension or facing any charge sheet or prosecution, he should not be allowed to assume charge of the post of Inspector, Group 'B' (Non-Gazetted) and this fact should be reported to his office immediately.


